

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (NTRO9765) affecting the A149 North Walsham Bypass from its junction with B1150 Norwich Road to its junction with C397 Withergate Road (the "Road") in the Town of North Walsham to facilitate surface dressing, main dressing and lining and stud replacement works, the Road will be temporarily closed (except for pedestrian access) for the duration of the works/period the closure is necessary which is anticipated to be from 26th June to 13th July 2025 only whilst signs indicating closures are in place, but may continue to be closed/restricted until the 30th January 2026 where the closure is still required beyond the anticipated dates. **NB: Phase 1 anticipated to be between 19:00 and 05:00 from 26th to 27th June, Phase 2 anticipated to be between 19:00 and 05:00 from 28th to 29th June 2025, Phase 3 anticipated to be between 19:00 and 05:00 from 12th to 13th July 2025.**

Alternative route is via: A149 North Walsham Bypass, A149 Yarmouth Road, A149 Norwich Road, A149 Wayford Road, B1159 Stepping Stone Lane, B1159 Stalham Road, B1159 Coast Road, B1159 Walcott Road, B1159 Coast Road, B1159 Paston Road, B1159 Bacton Road, C634 Bacton Road, C634 Mundesley Road, C634 Stow Hill, C634 Paston Road, C635 Water Lane, B1145 Knapton Road, B1145 Mundesley Road, B1145 North Walsham Road, B1145 Knapton Road, B1145 The Street, B1145 North Walsham Bypass, A149 North Walsham Bypass (East Ruston, Stalham, Dilham, Swafeld, Paston, Smallburgh, Bacton, Brumstead, Mundesley, Worstead, Walcott, North Walsham, Knapton).

The works promoter for this restriction/closure is: Norfolk County Council

Vehicular access will be permitted to a final destination in the Road where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works when the closure is no longer necessary or otherwise on the 30th January 2026 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.

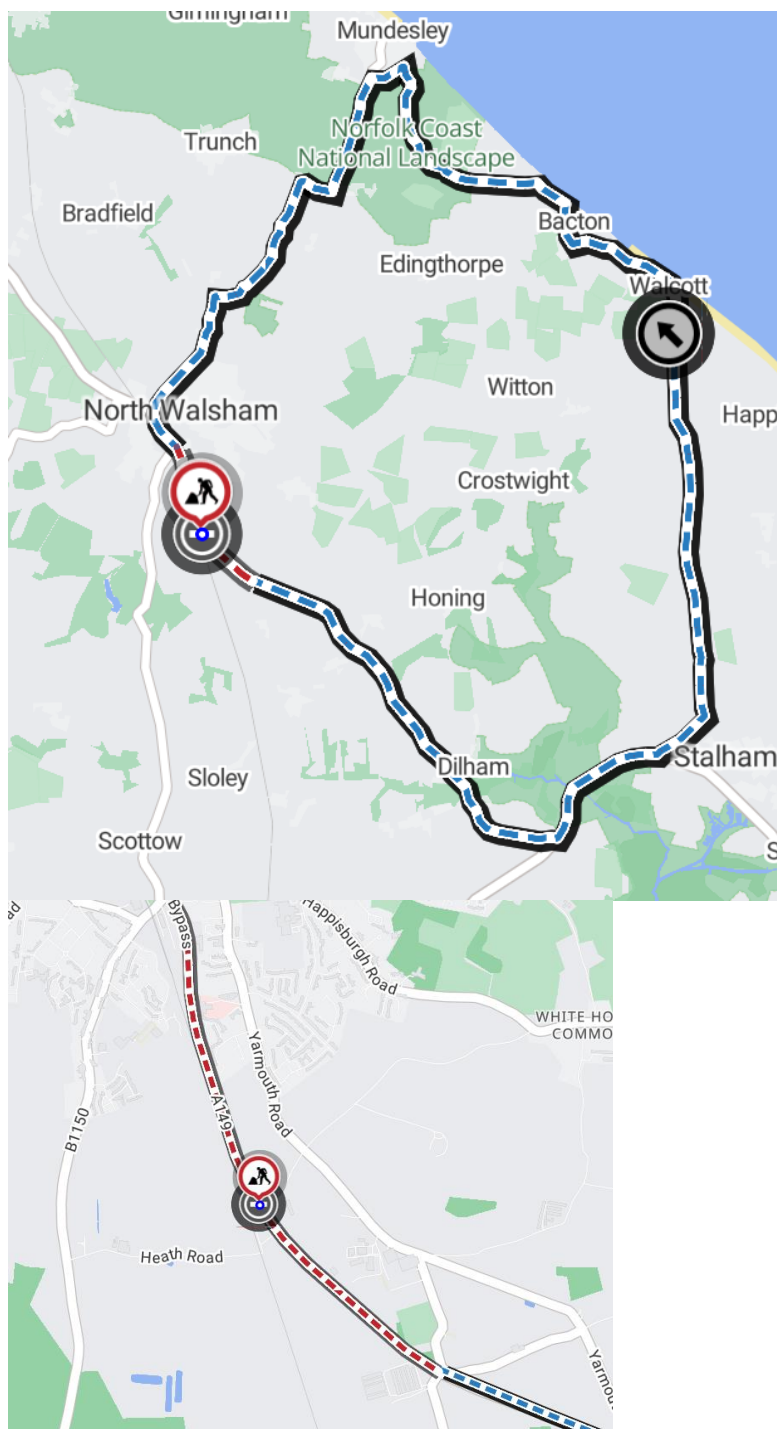
