Ordinary Full Parish Council Meeting held at 7pm on 11th December 2023 in the Village Hall, The Street, Swafield

Speed monitoring devices have been installed on the roads in Swafield after another accident on the 22nd November 2023, opposite The Rectory. Highways have also installed reflective posts either side of the bridge, this is a good start to improving road safety but more needs to be done. A public meeting will be held on the 23rd January 2024 to discuss issues regarding road safety.

Installation of village gates using the Parish Partnership scheme would be investigated. The Planning Committee at NNDC would be meeting in the new year to discuss planning application PF/23/1580 Land east of Lincoln Cottage. Members of the public will be able to attend.

Fliers were sent to the residents in Bradfield asking them to join the council, so that their views can be heard. To date no one from Bradfield has applied to join the council.

Cllr Ed Maxfield, County Councillor, sent in his report which is available on the website. He reported that the County Deal was moving forward and spoke about the elections in May 2025. Cllr Maxfield would like feedback regarding road clearing and gritting.

The road improvements for Swafield are being held up and are awaiting the results from the inquest into the fatal accident that happened on the Swafield Road.

Cllr Peter Neatherway, District Councillor, spoke about the increased house building in the North Walsham, Cromer and Fakenham areas, which would all have an impact on the roads

in the district caused by the increase of vehicles generated by these housing developments. PC Alex Barnes, Beat Manager, North Walsham Police, reported that there have been no crimes reported in Swafield and Bradfield and put forward some suggestions to improve road safety relating to the bridge.
