Emergency Notice
Temporary Traffic Regulation Order 2026
Section 14(2) of the Road Traffic Regulation Act 1984

Colby and Banningham (NTRO10909) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to a burst water main the use by vehicles (of any class) of the B1145 North Walsham Road from its junction with U14239 Mill Road for 50 metres north-eastwards (the "Road") in the Parish of Colby and Banningham will be temporarily prohibited/restricted.

Alternative route is via: B1145 North Walsham Road/ Banningham Road, A140 Aylsham Bypass/ Cromer Road/ Norwich Road, A149 Cromer Road, B1145 Greens Road/ Aylsham Road/ North Walsham Road/ Aylsham Road/ North Walsham Road (Erpingham, Swafield, Alby with Thwaite, Felmingham, Thorpe Market, Aylsham, Antingham, Northrepps, Southrepps, Hanworth, Roughton, North Walsham, Colby and Banningham).

The works promoter for this restriction/closure is: Anglian Water.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 6th to 12th February 2026 but the Road may continue to be closed/restricted until the 26th February 2026 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 26th February 2026 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.


