MINUTES

 APOLOGIES FOR ABSENCE – To note and approve apologies received by the Clerk prior to the meeting.
 Apologies were received from Mr Bob Clabon, Mr Michael Starling and Mr Timothy Payne – all personal and these were accepted by the Council.

2. DECLARATIONS OF INTEREST AND DISPENSATION-

To receive declarations of interest in agenda items and individual dispensations. There were no declarations or dispensations received.

- 3. MINUTES To approve the minutes of the Extra-Ordinary meeting of Saturday 21st May 2022
 It was resolved that these be approved and signed by the Chair.
- 4. ADJOURNMENT to receive NNDC & NCC and comments from members of the public and those with a disclosable interest in Agenda items

Resolved to open the meeting to the public.

Ed Maxfield, NCC – outlined his written report which had been circulated to members in advance. Discussion took place on the Community Road Safety Fund and that this scheme could not be utilised for a 20mph zone or adjusting the speed limit. However the NCC Parish Partnership Fund could support a feasibility study which cost circa £3k. Ed Maxfield would be prepared to fund 50% of this from his Highways budget.

It was further discussed that an application to the Community Road Safety Fund for an additional SAM2 and 30mph roundels through the Village could be made.

Resolved to close the meeting to the public.

5. FINANCE

- **To receive bank reconciliation and note receipts and review reserves**The Clerk outlined the bank reconciliation and reserves were noted.
- 5.2 To consider the purchase of a defibrillator including cabinet for Bradfield; to be located at Bradfield Cricket Club (£1,885 plus VAT and delivery costs)

The Clerk had sourced a quotation from CHT for the purchase of a defibrillator to cover the Bradfield part of the village. Members discussed this at length and financial orders were suspended to enable the correct item to be purchased to run in tandem with the unit located in Swafield. It was resolved that the Council purchase the defibrillator for the benefit of the community and that it be placed on Bradfield Cricket Club's building. The agreement to be that Bradfield Cricket Club paid for the installation, electricity and managed the unit on the CHT website.

The Clerk would liaise and arrange this.

7.4 Installation of new bus shelter

The Clerk informed that NCC did not require the cheque which had been sent to contribute towards the bus shelter. The Parish Council has to fund this project completely and then reclaim the contributed funds awarded from NCC. The Clerk will contact Westcotec to arrange a Proforma and forward this to NCC. It was hoped that the bus shelter would be in situ soon.

7.5 Meeting with Knapton and Mundesley Parish Councils re SAM2 and speed along the Knapton Road

The Clerk would arrange a meeting for August.

7.6 To agree actions for the NCC proposed funding Highways Scheme towards the reduction in speed within the Swafield-Knapton and Mundesley Parishes

Unfortunately, the Norfolk Road Safety Measures fund did not support a 20mph speed change. It was agreed that although disappointing an application could be made to the Parish Partnership Scheme. This would fund a feasibility study for this initiative. Ed Maxfield would contribute £1,500 towards this project with the other 50% being derived from the NCC Parish Partnership Scheme.

This would cover a 20mph zone through The Street, Swafield together with a 40mph restriction along the Knapton Road AGENDA

It was agreed that the Council applies to the NCC Road Safety Measures Fund to purchase an additional SAM2 and 30mph roundels within the village.
